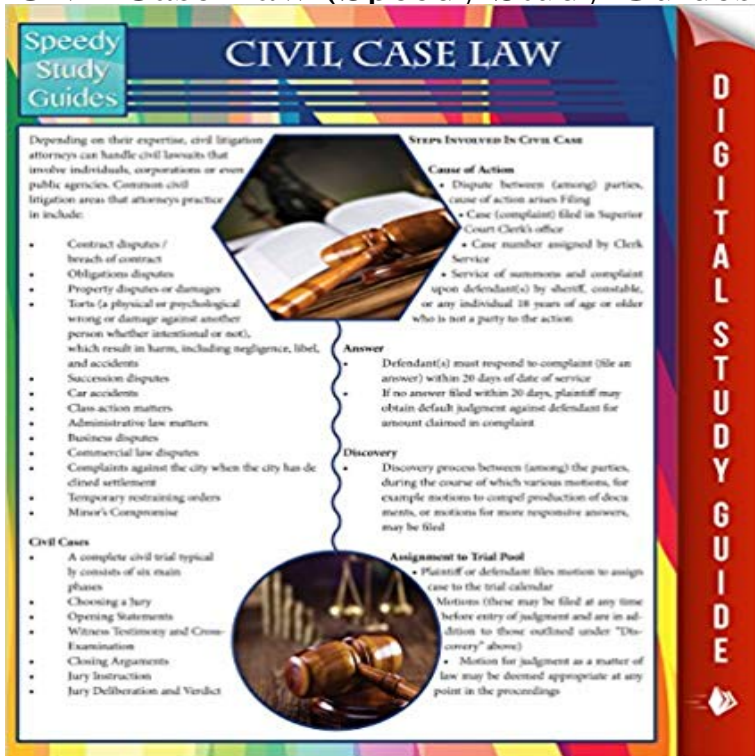


Civil Case Law (Speedy Study Guides)
