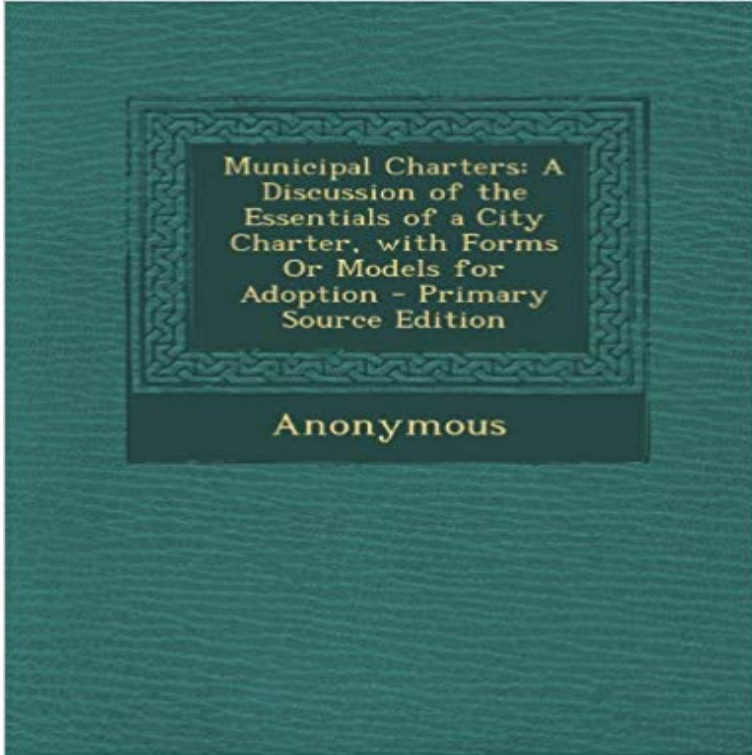


Municipal Charters: A Discussion of the Essentials of a City Charter, with Forms Or Models for Adoption - Primary Source Edition
