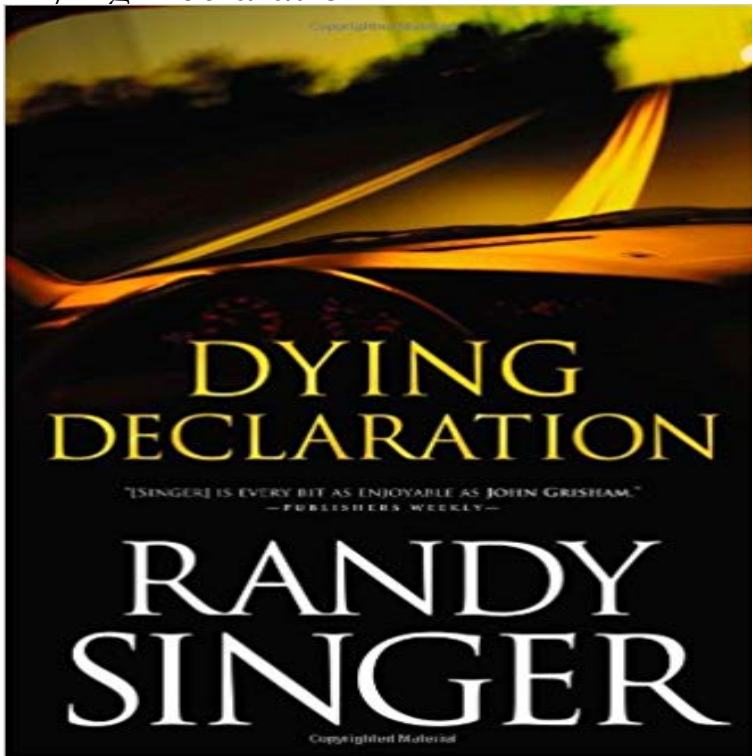


Dying Declaration
