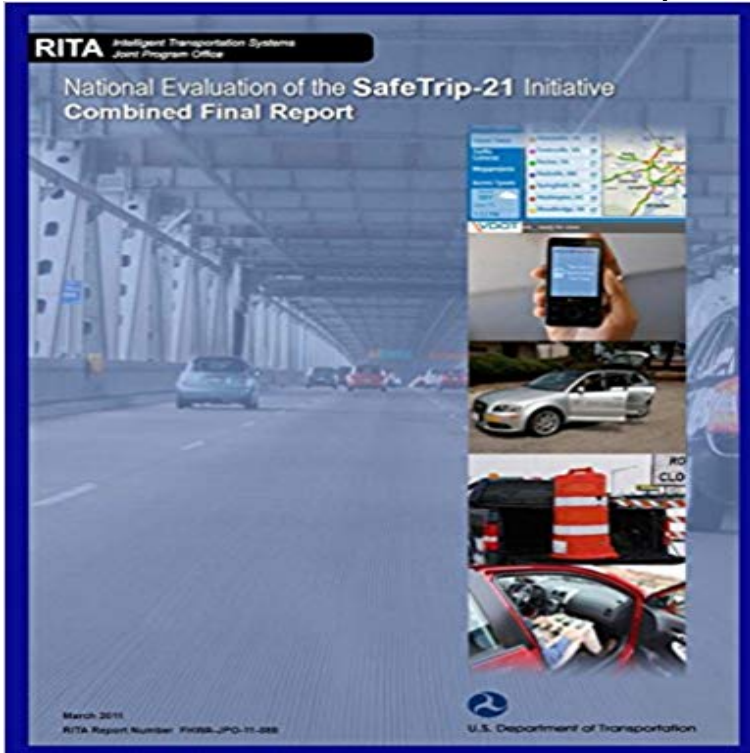


# National Evaluation of the Safetrip-21 Initiative: Combined Final Report
